- 6) A \$25.00 Victoria Point Shopping Centre Gift Card will be given to a customer who makes an eligible purchase at Victoria Point Shopping Centre between Monday 9<sup>th</sup> September and Saturday 14<sup>th</sup> September 2019 at any of the eligible retailers as per clause five (5).
- 7) Receipts must be presented to the Centre Management Office to receive a \$25.00 Victoria Point Shopping Centre Gift Card during the promotional period Monday 9<sup>th</sup> September – Saturday 14<sup>th</sup> September 2019. See clause eleven (11) for Centre Management Office operating hours.
- 8) A maximum of four receipts can be combined to reach the \$100.00 spend. An "Eligible Purchase" is a purchase:

- 9) An Eligible Purchase must be evidenced by an original official store receipt from an eligible retailer at the Centre that is clearly marked with the date, the amount of the purchase, and the retailer's trading name.
