DEFINITIONS

For the purpose of these Terms and Conditions:

"Entrants" refers to any person who enters or participates in the 'Promotion'.

"**Prizes**" refers to the prizes described in the 'Prize Pool Schedule' to be awarded by the Promoter in conjunction with the Promotion.

"Promoter" refers Lipoma Pty Ltd, (the trading name Victoria Point Shopping Centre).

- b) Is located within our Primary, Secondary and Tertiary Trade Areas of Victoria Point Shopping Centre as determined by Victoria Point Shopping Centre and
- c) Agrees to copy & distribute either electronically or in hard copy our weekly or fortnightly newsletters to all students of the School, displays promotional signage/posters and in their School newsletters during the promotional period.

"Qualifying Spend" refers to the minimum spend required listed below "Eligible Retail Purchase".
