

REWARDS CARD - TERMS AND CONDITIONS (COMPETITION)

DEFINITIONS

For the purpose of these Terms and Conditions:

The term **'Retailers'** refers to all participating Specialty Stores and Majors at Victoria Point Shopping Centre only.

The terms **'Gift Card'** and **'Gift Cards'** refers to Victoria Point Shopping Centre Gift Cards.

'Prize' refers to the prizes described in clause 3 to be awarded by the Promoter in conjunction with the Promotion.

'Rewards Card' refers to the card received by a customer which can be stamped when \$20 is spent at a retailer within Victoria Point Shopping Centre. Customers can obtain a Rewards Card from Centre Management or from the Promotions Booth, when staffed.

ELIGIBLE ENTRANTS

Entrants must be 15 years or older to enter the promotion and may only enter this Promotion in adherence to the below "Eligible Retail Purchases". Entrants aged 15,16 or 17:

- a) Must have prior consent from their parent or guardian before entering the Promotion and must be able to provide evidence of such consent on request; and
- b) Shall have a Prize awarded to their nominated parent/guardian upon presentation of photo identification if they win and the parent/guardian shall be deemed the Winner for the purposes of these terms and conditions.

ELIGIBLE RETAIL PURCHASES

The term **'Eligible Retail Purchases'** refers to any Retail Purchase made at a participating retailer at the "Shopping Centre" during the Promotional Period.

Minimum spend of \$20 in a single transaction at specialty stores and major stores will be accepted. Each Retail Purchase must be evidenced by the original transaction receipt. The following purchases are EXCLUDED for the purposes of the Promotion:

- a) Transaction receipts for travel purchases over \$5,000;
- b) All retailer gift vouchers and gift cards
- c) Victoria Point Shopping Centre, Centre Management gift or gift cards;
- d) Payments for rates, gas, electricity, telephone accounts, vehicle registrations, subscriptions to health funds and/or ambulance subscriptions and the like;
- e) Postage, deposits into banks, building societies or other financial institutions or payments on account of insurances and the like;
- f) telephone, internet or mobile phone calling cards or credit vouchers;
- g) A purchase of an item on lay-by or a similar scheme is deemed not to be an Eligible Purchase. Final closing payments of a layby however during the promotional period will be accepted;
- h) The purchase of any goods or services at the Centre that are not for personal consumption or use or are intended to be resold is deemed not to be an Eligible Purchase;
- i) Lotteries, Scratchies or any gambling purchases
- j) EFTPOS transactions, except where there is a retail purchase component. This excludes additional money debited for personal use at the time of the retail purchase;
- k) Business purchases over \$5,000.
- l) Online purchases excluding Click and Collect services provided by Coles, Kmart, Best & Less and Lenard's Chicken.
- m) The purchase of liquor, tobacco or tobacco products.
- n) Receipts being submitted for validation must not exceed three (3) months from date of purchase.

PRIZE

Winners will be drawn on the first business day in the following month at 11am. The first card drawn will receive one (1) \$100 Victoria Point Shopping Centre Gift Card, the second card drawn will receive one (1) \$50 Victoria Point Shopping Centre Gift Card and the third card drawn will receive one (1) \$25 Victoria Point Shopping Centre Gift Card. Winners will be contacted by phone

and their first name and suburb, as displayed on the Rewards Card, will be displayed in the Centre Management office located in the Shopping Centre.

HOW TO ENTER

To be eligible to enter this promotion, Eligible Entrants must make an Eligible Retail Purchase to the value of \$20.00 in a single transaction from the Shopping Centre and present receipts to Centre Management located at the Shopping Centre or the Promotions Booth when staffed, to receive one stamp on the Rewards Card. Once all twenty (20) boxes are stamped, the Entrant must complete their details on the Rewards Card and hand it to a Victoria Point Shopping Centre Representative. The Rewards Card will then be placed into the monthly draw at Centre Management for their chance to win the prize/s.

Centre Management hours of operation are 9:00am – 5:00pm Monday to Friday, 9am – 4pm Saturday. Please note that Centre Management is closed on Sundays and public holidays.

GENERAL

Information on how to register and prizes form part of these terms and conditions. The entrant agrees and acknowledges they have read these Terms and Conditions. Entry into the Promotion, is deemed acceptance of the Terms and Conditions including entry by Entrants, Retailers, Employees (and their immediate family members), Contractors, distributors and suppliers. Customers are not eligible to enter this Promotion if they are immediate family members of employees of Victoria Point Shopping Centre retailers, Centre Management employees and contractors.

Entrants receipts evidencing Eligible Retail Purchases will not be kept by the Promoter but will be witnessed and verified with a stamp by a Victoria Point Shopping Centre Representative and returned to the Entrant. Stamped and verified receipts cannot be re-presented for the same promotion. The Promoter reserves the right to contact retailers to confirm whether any presented receipts comes from a store located within the Shopping Centre.

The Promotion commences on the Start Date and end on the End Date (the "Promotional Period"). Entries deemed to be received at the time of receipt by the Promoter and not at the time of at the time of transmission by the entrant.

Prohibited Behaviour includes, but is not limited;

- a) Soliciting for receipts within Victoria Point Shopping Centre or car park by standing outside store entrances asking for receipts and searching through trolleys or bins
- b) Asking Retailers for unclaimed receipts or duplicate receipts
- c) Presenting receipts that have previously been entered i.e. duplicate receipts
- d) Presenting forged receipts or receipts that been materially altered
- e) Presenting receipts for goods already returned or failing to advise the Promoter to delete pre-accrued points for goods subsequently returned

Any Rewards Card accumulated through Prohibited Behaviour will result in any of the following actions:

- f) Refusal by Victoria Point Shopping Centre to include the Rewards Card
- g) Disqualification of the Customer to enter the promotion

Victoria Point Shopping Centre Gift Cards cannot be transferable for cash and these gift cards are subject to their terms and conditions or use.
