- 2) Entry into the promotion is deemed acceptance of these terms and conditions.
- 3) The promotion commences at 9:00am on Monday 23<sup>rd</sup> November 2020 and ends 3:00pm on Sunday 29<sup>th</sup> November 2020.  
**One (1) Gift Card per person per day, with a maximum of Two (2) Gift Cards per person in total during promotional period.**
- 4) Refer to Annex A for 'Eligible Stores' stores are defined as all participating and eligible Specialty Stores.
- 5) A \$20.00 Victoria Point Shopping Centre Gift Card will be presented to a customer who makes an eligible purchase at Victoria Point Shopping Centre between Monday 23 November 2020 and Sunday 29 November 2020 at any of the eligible retailers as per clause four (4).
- 6) Receipts must be presented to the Promotional Booth to receive a \$20.00 Victoria Point Shopping Centre Gift Card during the promotional period.
- 7) A maximum of two receipts can be combined to reach the \$100.00 spend. An "Eligible Purchase" is a purchase:
  - a) At any eligible store see clause four (4), but these must not be:
    - I. A purchase of an item on lay-by or a similar scheme is deemed not to be an Eligible Purchase. Final closing payments of a lay-by however during the promotional period will be accepted.
    - II. The purchase of any goods or services at the Centre that are not for personal consumption or use or are intended to be resold is deemed not to be an Eligible Purchase.
