

## Victoria Point Shopping Centre 2024 Mother's Day Promotion

### Terms and Conditions of Entry

- 1) Centre staff & immediate family, Centre Management and immediate family and contractors and immediate family of Victoria Point Shopping Centre are ineligible to participate in this promotion.
- 2) Entry into the promotion is deemed acceptance of these terms and conditions.
- 3) This Promotion is only open to **Qld residents** aged 18 years or over, unless the participant has a parent or guardian's permission to participate in the Promotion; If a Prize recipient is under the age of 18 years, the parent or guardian who gave permission for participation in the Promotion will be deemed to be the Prize recipient for the purposes of the Promotion.
- 4) The promotion opens at 7am on Monday 29<sup>th</sup> April and closes Saturday 11<sup>th</sup> May 2024 at 2.00pm.
- 5) **Strictly one entry per person for each eligible receipt/s per day. A eligible receipt can only be use once during the promotion.**
- 6) To enter, customers must make an Eligible Purchase at a Victoria Point Shopping Centre retailer. An eligible purchase is either a purchase to the value of \$40 or more at any specialty store (a maximum number of 2 receipts can be combined to make up the \$40 value) or a purchase of \$100 or more at Coles, Woolworths or Kmart. Present your eligible receipt/s to the promotional booth located in Centre.
- 7) Receipt/s must be presented to the promotional staff at the promotional booth to enter the competition once the purchase has been verified. See clause ten (a), (10a) for booth operating hours.
- 8) A maximum of two receipts can be combined to reach the \$40 (forty dollars) total from specialty stores.
- 9) An "Eligible Purchase" is a purchase:
  - a) of any goods or services from a Specialty Store to the value of \$40 (forty dollars), or Woolworths, Coles, Kmart to the value of \$100 (one hundred dollars), but these must not be:
    - i) gift vouchers or gift cards; or
    - ii) payments for rates, gas, electricity, telephone accounts, vehicle registrations, subscriptions to health funds and/or ambulance subscriptions; or
    - iii) postage, deposits into banks, building societies or other financial institutions or payments on account of insurances and the like; or
    - iv) telephone, internet or mobile phone calling cards or credit vouchers;
    - v) A purchase of an item on lay-by or a similar scheme is deemed not to be an Eligible Purchase. Final closing payments of a layby however during the promotional period will be accepted;
    - vi) The purchase of any goods or services at the Centre that are not for personal consumption or use or are intended to be resold is deemed not to be an Eligible Purchase;
    - vii) Lotteries or Scratchie purchases;
    - viii) Liquor or Cigarette purchases.
  - b) An Eligible Purchase must be evidenced by an original official store receipt from a Specialty retailer or Coles, Woolworths or Kmart at the Centre that is clearly marked with the date, the amount of the purchase, and the retailer's trading name.
- 10) The eligible purchase must be made during the promotional period of 29<sup>th</sup> April – 12<sup>th</sup> May 2024.
  - a) **A prize will be provided when eligible receipt/s are presented at the promotional booth during the booth operating hours (as displayed at the booth). The operating hours are from 10.00am - 2.00pm from Wednesday 8<sup>th</sup> May to Saturday 11<sup>th</sup> May 2024. Customers are to select a numbered door from the Mystery Door cabinet. Behind each door is a golden ticket which documents the prize from a selected Retailer at Victoria Point Shopping Centre. The Customer will win the prize from the door selected. Only one prize per customer per day with each eligible receipt.**
- 11) Total of 400 (four hundred) prizes to be collected between 8<sup>th</sup> May 2024 – 12<sup>th</sup> May 2024. A limit of 100 prizes will be allocated per day.
  - a) Prize – includes a \$25 gift voucher from selection of stores at Victoria Point Shopping Centre. Prize must be redeemed at the selected store on the gift voucher at Victoria Point Shopping Centre.
- 12) **The gifts are offered by Victoria Point Shopping Centre in good faith and are not exchangeable or redeemable for cash.**
