

## Victoria Point Shopping Centre 2025 Spin to Win

### Terms and Conditions of Entry

- 1) Centre staff & immediate family, Centre Management and immediate family and contractors and immediate family of Victoria Point Shopping Centre are ineligible to participate in this promotion.
- 2) Entry into the promotion is deemed acceptance of these terms and conditions.
- 3) This Promotion is only open to **Qld residents** aged 18 years or over, unless the participant has a parent or guardian's permission to participate in the Promotion; If a Prize recipient is under the age of 18 years, the parent or guardian who gave permission for participation in the Promotion will be deemed to be the Prize recipient for the purposes of the Promotion.
- 4) The promotion opens at 7am on Tuesday 14<sup>th</sup> January and closes Saturday 18<sup>th</sup> January at 1.00pm.
- 5) **Strictly one entry per person for each eligible receipt per day. An eligible receipt can only be used once during the promotion.**
- 6) To enter, customers must make an Eligible Purchase at a Victoria Point Shopping Centre retailer. An eligible purchase is either a purchase to the value of \$20 in a fast food or food takeaway outlet, \$40 or more at any specialty store, or a purchase of \$100 or more in Coles, Woolworths or Kmart in a single transaction. Present your eligible receipt to the promotional booth located in Centre.
- 7) Receipt must be presented to the promotional staff at the promotional booth to be eligible to spin the wheel, once the purchase has been verified. See clause ten (a), (10a) for booth operating hours.
- 8) An "Eligible Purchase" is a purchase:
  - a) of any goods or services to the value of \$20 (twenty dollars) from a fast food or food takeaway outlet or \$40 (forty dollars) from a Specialty Store, or \$100 (one hundred dollars) from Woolworths, Coles, Kmart, but these must not be:
    - i) gift vouchers or gift cards; or
    - ii) payments for rates, gas, electricity, telephone accounts, vehicle registrations, subscriptions to health funds and/or ambulance subscriptions; or
    - iii) postage, deposits into banks, building societies or other financial institutions or payments on account of insurances and the like; or

- iv) telephone, internet or mobile phone calling cards or credit vouchers;
  - v) A purchase of an item on lay-by or a similar scheme is deemed not to be an Eligible Purchase. Final closing payments of a layby however during the promotional period will be accepted;
  - vi) The purchase of any goods or services at the Centre that are not for personal consumption or use or are intended to be resold is deemed not to be an Eligible Purchase;
  - vii) Lotteries or Scratchie purchases;
  - viii) Liquor or Cigarette purchases.
- b) An Eligible Purchase must be evidenced by an original official store receipt from a Fast Food outlet, a Specialty retailer or Coles, Woolworths or Kmart at the Centre that is clearly marked with the date, the amount of the purchase, and the retailer's trading name.
- 9) The eligible purchase must be made during the promotional period of 14<sup>th</sup> January – 18<sup>th</sup> January 2025.
- a) **A Customer will have an opportunity to spin the wheel to reveal a prize once the eligible receipt is presented at the promotional booth during the booth operating hours (as displayed at the booth). The operating hours are from 10.00am - 1.00pm from Tuesday 14<sup>th</sup> January 2025 to Saturday 18<sup>th</sup> January 2025 . The booth may close earlier than the advertised time if the daily allocation of prizes have been exhausted. Only one prize per customer per day with each eligible receipt.**
- 10) Total of 500 (five hundred) prizes are available between 14<sup>th</sup> January 2025 – 18<sup>th</sup> January 2025. A limit of 100 prizes will be allocated per day.
