

**Victoria Point Shopping Centre 2025 Mother's Day Promotion –  
“A Picnic on Us”**

**Terms and Conditions of Entry**

- 1) Centre staff & immediate family, Centre Management and immediate family and contractors and immediate family of Victoria Point Shopping Centre are ineligible to participate in this promotion.
- 2) Entry into the promotion is deemed acceptance of these terms and conditions.
- 3) This Promotion is only open to **Qld residents** aged 18 years or over, unless the participant has a parent or guardian's permission to participate in the Promotion; If a Prize recipient is under the age of 18 years, the parent or guardian who gave permission for participation in the Promotion will be deemed to be the Prize recipient for the purposes of the Promotion.
- 4) The promotion opens at 7am on Monday 28<sup>th</sup> April and closes Saturday 10<sup>th</sup> May 2025 at 2.00pm.
- 5) **Strictly one entry per person for each eligible receipt per day. An eligible receipt can only be use once during the promotion.**
- 6) To enter, customers must make an Eligible Purchase at a Victoria Point Shopping Centre retailer. An eligible purchase is either a minimum purchase of \$20 from a fast food takeaway or restaurant, \$40 or more at any specialty store, or a purchase of \$100 or more from Coles, Woolworths or Kmart. Present your eligible receipt to the promotional booth located in Centre.
- 7) The eligible Receipt must be presented to the promotional staff at the promotional booth to receive a gift once the purchase has been verified. See clause ten (a), (10a) for booth operating hours.
- 8) One receipt per customer per day to receive a gift.
- 9) An “Eligible Purchase” is a minimum purchase:
  - a) Of \$20 from a Fast Food Takeaway or Restaurant, \$40 (forty dollars) from a Specialty store, or \$100 (one hundred) from Woolworths, Coles, Kmart but not including:
    - i) gift vouchers or gift cards; or
    - ii) payments for rates, gas, electricity, telephone accounts, vehicle registrations, subscriptions to health funds and/or ambulance subscriptions; or

- iii) postage, deposits into banks, building societies or other financial institutions or payments on account of insurances and the like; or
  - iv) telephone, internet or mobile phone calling cards or credit vouchers;
  - v) A purchase of an item on lay-by or a similar scheme is deemed not to be an Eligible Purchase. Final closing payments of a layby however during the promotional period will be accepted;
  - vi) The purchase of any goods or services at the Centre that are not for personal consumption or use or are intended to be resold is deemed not to be an Eligible Purchase;
  - vii) Lotteries or Scratchie purchases;
  - viii) Liquor or Cigarette purchases.
- b) An Eligible Purchase must be evidenced by an original official store receipt from a Fast Food takeaway or Restaurant, Specialty retailer or Coles, Woolworths or Kmart at the Centre that is clearly marked with the date, the amount of the purchase, and the retailer's trading name.
- 10) The eligible purchase must be made during the promotional period of 28<sup>th</sup> April to 10<sup>th</sup> May 2025.
- a) **A gift will be provided when an eligible receipt is presented at the promotional booth during the booth operating hours (as displayed at the booth). The operating hours are from 10.00am - 2.00pm from Thursday 8<sup>th</sup> May to Saturday 10<sup>th</sup> May 2025 or when the number of allocated prizes per day have been exhausted. This may mean the booth may close before the advertised operating hours. Customers will collect the daily prize on offer. Only one gift per customer per day with an eligible receipt.**
- 11) A total of 300 (three hundred) gifts have been allocated between 8<sup>th</sup> May – 10<sup>th</sup> May 2025. A limit of 100 gifts will be allocated per day.
- a) Gift -:
- 1. Day 1 – 8<sup>th</sup> May – branded Victoria Point Shopping Centre cheese board.
  - 2. Day 2 – 9<sup>th</sup> May – branded Victoria Point Shopping Centre picnic blanket.
  - 3. Day 3 – 10<sup>th</sup> May – small packaged mixed food platter
