

Victoria Point Shopping Centre – ‘Boredom Buster’ Prize Pack Competition

Terms and Conditions

Promoter

The competition is conducted by Lipoma Pty Ltd trading as Victoria Point Shopping Centre, 2/34 Bunker Rd, Victoria Point QLD 4165 ABN 65 002 203 581 (“the Promoter”).

Competition Period

The competition commences at 9:00am on Thursday 17 September 2026 and concludes at 5:00pm on Friday 25 September 2026 (“the Competition Period”).

Eligibility

- a. Entry is open to all visitors to Victoria Point Shopping Centre during the Competition Period.
- b. Entrants must be 18 years of age or older. If a winner is under 18 years of age, the prize will be awarded to their parent or legal guardian.
- c. Employees of the Promoter and their immediate families are not eligible to enter.

How to Enter

- a. To enter the Competition, entrants must make an eligible purchase at Victoria Point Shopping Centre during the Competition Period and retain their receipt.
- b. A eligible purchase is:
 - Of any goods or services from a fast food retailer or dine-in retailer to the value of \$10 or more in a single transaction, a specialty store to the value of \$30 or more in a single transaction, or Woolworths, Coles, Kmart to the value of \$50 or more in a single transaction, but these must not be:
 - Gift vouchers or gift cards; or
 - Payments for rates, gas, electricity, telephone accounts, vehicle registrations, subscriptions to health funds and/or ambulance subscriptions; or
 - Postage, deposits into banks, building societies or other financial institutions or payments on account of insurances and the like; or
 - Telephone, internet or mobile phone calling cards or credit vouchers;
 - A purchase of an item on lay-by or a similar scheme is deemed to not be an eligible purchase. Final closing payments of a layby however during the promotional period will not be accepted;
 - Purchase of any goods or services at the Centre that are not for personal consumption or use or are intended to be resold is deemed to not be an eligible purchase;
 - Lotteries or Scratchie purchases;
 - Liquor or Cigarette purchases.
 - An eligible purchase must be evidenced by an official store receipt from a food outlet, restaurant, specialty retailer or Coles, Woolworths or Kmart at the Centre that is clearly marked with the date, amount of the purchase, and the retailer’s trading name.
 - All shopping receipts must be dated between the Promotional Period and must have the store/identity clearly printed on it.
- c. Entrants must write their full name and email address on the back of their eligible receipt and place the receipt in the competition entry barrel located near Best & Less.
- d. Each eligible receipt constitutes one entry into the Competition.
- e. Entrants may enter multiple times during the Competition Period, provided that a new eligible receipt

is submitted for each entry.

f. The Promoter reserves the right to verify the validity of any receipt and may request the original receipt or other reasonable evidence of purchase.

g. Incomplete, illegible or otherwise ineligible entries may be deemed invalid at the Promoter's discretion.

Data Collection and Sharing

a. By entering the Competition, entrants acknowledge and consent to the Promoter collecting their personal information, including their name and email address, for the purpose of administering the competition and contacting the winner.

b. Entrants personal information will be collected from the details provided on their eligible entry receipt.

c. The Promoter will only use entrants' personal information for purposes connected with the Competition, unless otherwise permitted or required by law.

d. Entrants' information will be handled in accordance with the Promoter's Privacy Policy, available on the Victoria Point Shopping Centre website.

Prize Draw

a. One (1) winner will be selected at random from all eligible entries received in the Competition entry barrel during the Competition Period at 10am on Monday 28 September 2026 at the Centre Management office of Victoria Point Shopping Centre, 2/34 Bunker Rd, Victoria Point QLD 4165.

b. The draw will take place in private, and no entrants or members of the public will be permitted to attend.

c. The Promoter's decision is final, and no correspondence will be entered into.

Winner Notification and Prize Collection

a. The winner will be contacted by email using the details provided on their entry form.

b. The winner will also be announced on the Victoria Point Shopping Centre website following the draw.
